These completed forms will assist the Area Treasurer in the preparation of the annual budget, and provide the voting body an opportunity to view the listed expenses.

This recommendation has been added to the updated version of the Area 82 Guidelines. The anticipated budget forms are housed on the Area 82 website. Once these forms are completed,

submitted to the Area Treasurer, and presented during the budget portion of the agenda, it will become the responsibility of the voting body of Area 82 to review the Anticipated Budget Form and will become the decision of the voting body to approve or deny those expenses. We will see how this new tool works moving forward. This will address the concern raised earlier from District 3.

#### **ALT GSD REPORT**

Good morning, friends, my name is Dwayne, and I'm an alcoholic. I am a member of the Hope Group in New Glasgow, NS, and have the honour of serving as your Alternate General Service Delegate for Panel 73. The year has been a busy one for both myself and the GSD. We travelled to St. Catherine's, ON for the Canada East Region Alcoholics Anonymous Service Assembly, or CERAASA, in February. I was asked to do a presentation on the use of the 12 Traditions Across the Groups. This presentation was given to approximately 300 members. I was very nervous and talked so fast that the interpreters had to ask me to slow down. Seriously, I broke the interpreters. The presentation was very well received. While at CERAASA, I also attended a General Service Conference preparation workshop with our GSD, Gerry After the closing of the conference, Myself, Gerry, and Past Delegate, Trudy D. attended a meeting with the CERAASA Steering Committee. Area 82 is the next Area in the rotation to host the conference in 2025. It will be held in HRM and will have members from all ten areas from Eastern Canada. Gerry, Trudy, and I are serving on the steering committee, and along with the GSDs and AGSDs from the other 9 Areas in Eastern Canada, meet monthly on Zoom to plan the conference. Make your plans now, folks. All members are welcome, and quite a few volunteer members will be needed. Following the CERAASA guidelines, Trudy, as the immediate past delegate of the host area, has assumed the role of CERASSA Chair. In my role as AGSD, I have also chaired monthly Active Area Committee meetings on Zoom. All members are welcome at these meetings as well. They take place on the last Monday of the month at 6:30 pm NL time, 6pm Atlantic. It is a place for discussion of what is happening in committees in the districts and groups across the area, and a place where people wanting to take part in service can come and ask questions and listen to and take part in the discussion. I know I have learned a lot by attending these sessions, and many great ideas are passed between participants. Information on the time and Zoom ID can be found on the Area Website www.area82aa.org.We are still seeking Co-chairs for Active Area Committees in both Newfoundland and Nova Scotia. The elected Co-chairs of Committees assist and work with the Chair (Alt. Delegate) for the Committees. The Co-chairs, with direction of the Chair provide support in districts and groups to engage in building Committees in their own AA communities, pass on information from GSO, help set up committees in districts that do not have committees, help facilitate workshops, and provide any other assistance that may be required by the districts in their province to carry the message of Alcoholics Anonymous. In Newfoundland we require co-chairs for the Corrections, Grapevine, and Treatment Committees. In Nova Scotia the positions of Cooperation with the Professional Community, Public Information, Corrections, and Grapevine co-chairs are vacant. If you or a member you know are interested in doing AA Service in one of these positions, you may click on the Area 82 Positions tab on the Area 82 Website. The positions are listed, the resume template is there, and the instructions on how to inform the Area of your interest is there as well . I have also been asked, and have attended district meetings, both online and in person, to present workshops. Some of those workshops have just been a general presentation on Area 82 activities and finances, followed by a question-and-answer session. Others have been the earlier mentioned presentation on the 12 traditions with a Q&A. Either way, it's always a learning experience for me. Like taking a sponsee through the steps, I get to do them, too, and learn something new every time. I also regularly attend

our Remote Community AA Zoom meeting on Wednesday nights. This is a hybrid discussion meeting with members from Makkovik, Labrador, and several members from across Area 82, and other parts of Canada. It's a great meeting, feel free to Zoom in. Information can be found in the Area meeting list on the website. I have learned over the past 10 months that the position of Alt. GSD requires a lot of time, commitment, and hard work. My group meets three times a week, and I often miss home group meetings to attend online service meetings in my AGSD role. As well as the activities listed above, I had the honour of helping our GSD prepare for the General Service Conference. While he carried the bulk of the load, I had to tag along and be familiar enough with the agenda items for the conference to be prepared to step in to represent the Area if the GSD could not. Just for the record, I have forbidden Gerry to "could not". Although it is time and work intensive, I am thoroughly enjoying my time as Alternate General Service Delegate and thank the members of Area 82 for allowing me to fill the position for this rotation. For service nerds like me, the challenges of this position are a small price to pay for the joy and enhanced sobriety that come from the service I am able to perform. From Baccalieu Trail Group – There are still areas in our province where travel is a challenge, and many groups cannot afford to send a GSR in person. According to the 12 Traditions, Number 1 states "our common welfare comes first, personal recovery depends on AA unity". Number 2 states "for our group purpose there is only one ultimate authority, a loving God as He may express himself in our group conscience. Our leaders are but trusted servants, they do not govern." We believe this speaks to the need to have all voices heard. Tradition 3 states that "the only requirement for AA membership is a desire to stop drinking" It does not state that we need to contribute financially to send people on trips to have the voice of the Area heard, when there are other options that do not cost money. Although it has been discussed that money is not an issue to attend Spring and Fall Assemblies, there are still areas where this presents a challenge, especially in NL where the cost of travel can be quite high. We suggest making the Area Assemblies more accessible to all districts and groups, by providing option to attend via zoom. Finally, Tradition 12 states that "Anonymity is the spiritual foundations of all our Traditions, ever reminding us to place principles before personalities." We speak to this to ensure that the financial principles are taken into consideration, and not the wishes of just a few who want to have the meetings held only in person .This motion was presented and passed at District 14, to be presented to the Area Assembly. # **AD HOC GUIDELINES REPORT**

Ad hoc committee, guidelines, final report, October 7, 2023

Thank you for the opportunity and privilege to serve on this committee! To participate in this process with Heather, Jo, Leah, Samaira and Steven has been an opportunity for me to spend time with a wealth of experience and wisdom and not only learn more about our fellowship and program, but to be even more grateful, that by the grace of God, I am part of it. I also want to thank those people we reached out to for assistance throughout the process. We completed our review prior to the spring assembly in 2023 and an updated version of the guidelines including all corrections and motions we identified from the 2014 service weekend up to and including the service weekend in October of 2022 are reflected in version 5 dated May 15, 2023 which was posted on our area website within a week of completion of our spring assembly earlier this year. On June 12 this year, a year to the day after our first meeting, we sent out a list of 37 recommendations, some with a brief background, for distribution to as broad an audience in area 82 as possible so that all members would have an opportunity to be familiar with them and be prepared for this service weekend. "For our group purpose there is but one ultimate authority --- a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants, they do not govern." The group conscience of our committee is now passing these 37 recommendations on to the group conscience of area 82 for your consideration. Steven D. has graciously offered to present them to you, one at a time. While individual members of the committee are past the point of having an opinion on any of the recommendations, there are a few present today who may be able to answer any questions as to the background of the recommendations. "A.A. as such ought never be organized; but we may create service boards or committees directly responsible to those they serve." I have no idea why I have felt compelled to include the 9<sup>th</sup> tradition in this report other than to say that, for some time now, an

inner voice has been urging me to do so. I love the fellowship of alcoholics anonymous and the big book of alcoholics anonymous. You are giving me the best days of my life and for that, I thank you from the bottom of my heart! John Whelan

there were changes coming to light at this assembly. Are you aware of these changes,

and/or are there changes going to be made to these 37 recommendations?



Kevin from District 3 and I share this responsibility rotating every other month. We do this once a month on a Wednesday afternoon. It involves us identifying with clients as Alcoholics and explaining what Bridging the Gap is about. We also leave time for the Clients to ask questions about AA and meetings.
